Objective is to obtain cross section of vehicles with experienced drivers, safety, course setup, event chairs, etc. to provide assessment of site and pay sanction and insurance fee, not to exceed \$15. Reimbursement of lot fees or other costs should be sought from BMWCAA and PCA to extent of their participation to total participation.
- Proposal carries by unanimous vote of BOD members remaining.
