Attachment 1

For item 6.3.4, I would like to add:

Competitor must still compete in at least half of all championship events in one class.

If, by way of competition and use of average points for missed events, the competitor has more than two-thirds of the events with points, then any events which use average points are dropped first, before any events which the competitor actually competed in, even if the average is higher.
